## **ORDINANCE NO. 7-2018**

## ORDINANCE BY THE CITY COUNCIL OF THE CITY OF HARLOWTON, MONTANA, REPEALING CHAPTER 10.48 OF THE CITY OF HARLOWTON MUNICIPAL CODES CONCERNING RADAR TRAFFIC CONTROL.

## RECITALS

WHEREAS, the City Council has found that the existing Municipal Codes concerning a radar control unit for city police, are outdated and are now within the purview of the Wheatland County Sheriff's Office; and

WHEREAS, the City Council finds that repeal of Chapter 10.48 in its entirety, will address these issues:

**NOW, THEREFORE, BE IT ORDAINED,** by the City Council, City of Harlowton, Montana. as follows:

Section 1: Action

Chapter 10.48, which provides for a radar control unit to be used by city police, posting of signs indicative thereof, and penalties, is hereby repealed. The City of Harlowton now has an interlocal agreement with Wheatland County to provide police services within the city limits.

Section 2: Repealer

All resolutions, ordinances and sections of the City of Harlowton Municipal Code and Parts thereof in conflict herewith are hereby repealed.

Section 3: Severability

If any provision of this ordinance or the application thereof to any person or circumstances is held invalid, such invalidity shall not affect the other provisions of this ordinance which may be given effect without the invalid provision or application and, to this end, the provision of this ordinance is declared to be severable.

Section 4: Effective Date

The First Reading of this ordinance occurred on, and is reflected in the minutes of the City Council dated November 27, 2018.

This ordinance shall be in full force and effect 30 days after passage of the Second Reading.
