9.28.020 Unlawful to Set off or Explode Fireworks. It is unlawful to discharge fireworks within the City limits with the exception of the following:

1. On July 2, 3, and 4 from 8:00 a.m. to midnight (12:00 a.m.), each day, unless

Wheatland County is under fire restrictions; and,

2. On special occasions such as New Year's Eve, but only if a person submits an application to the City Clerk at least 14 days before the special event and the City Council grants written permission to the applicant at least 48 hours before the special event.

9.28.030 Penalties. Any person violating any of the provisions of this ordinance shall be deemed guilty of a misdemeanor and shall be punished by a fine of not less than five dollars (\$5.00) and not exceeding two hundred fifty dollars (\$250.00) and cost of prosecution, or by imprisonment in the city jail for a period of not less than five (5) days and not exceeding ninety (90) days, or by both said fine and imprisonment; in case said fine and cost of prosecution are not paid, the offender shall be committed to jail until such fine is paid at the rate of one (1) day for each two dollars (\$2.00) of said fine costs.
