

**ORDINANCE NO. 03-2019**

**ORDINANCE BY THE CITY COUNCIL OF THE CITY OF HARLOWTON, MONTANA, REPEALING SECTION 7.16.020 OF THE CITY OF HARLOWTON MUNICIPAL CODES CONCERNING REPEAL OR MODIFICATION OF ORDINANCE 83.**

**RECITALS**

**WHEREAS**, the City Council has found that the existing Municipal Codes Section 7.16.020, concerning repeal or modification of Ordinance 83, is not necessary as Ordinance 83 has been codified in Section 7.04.110; and

**WHEREAS**, the City Council finds that repeal of Section 7.16.020 will clarify the existing municipal Codes to eliminate any question whether the City Council may modify or amend Section 7.04.110 if deemed appropriate, thereby addressing this issue:

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council, City of Harlowton, Montana, as follows:

Section 1: Action

Section 7.16.020 is repealed.

Section 2: Repealer

All resolutions, ordinances and sections of the City of Harlowton Municipal Code in conflict herewith are hereby repealed.

Section 3: Severability

If any provision of this ordinance or the application thereof to any person or circumstances is held invalid, such invalidity shall not affect the other provisions of this ordinance which may be given effect without the invalid provision or application and, to this end, the provision of this ordinance is declared to be severable.

Section 4: Effective Date

The First Reading of this ordinance occurred on, and is reflected in the minutes of the City Council dated August 27, 2019.

This ordinance shall be in full force and effect 30 days after passage of the Second Reading.
