

**ORDINANCE NO. 07-2019**

**ORDINANCE BY THE CITY COUNCIL OF THE CITY OF  
HARLOWTON, MONTANA, REPEALING CHAPTER 10.54 OF THE  
CITY OF HARLOWTON MUNICIPAL CODES CONCERNING DRIVING  
ON SIDEWALKS.**

**RECITALS**

**WHEREAS**, the City Council has found that the existing Municipal Codes in Chapter 10.54, entitled "Driving on Sidewalks" includes unnecessary regulations controlling driving on sidewalks; and

**WHEREAS**, the City Council has found that the regulations in Chapter 10.54 are no longer necessary as they are otherwise covered by state laws; and

**WHEREAS**, the City Council finds that it is in the best interest of the City of Harlowton to repeal Chapter 10.54, including Sections 10.54.010 and 10.54.020, as provided below:

**NOW, THEREFORE, BE IT ORDAINED**, by the City Council, City of Harlowton, Montana, as follows:

**Section 1: Action**

The City Council proposes that Chapter 10.54, entitled "Driving on Sidewalks," should be removed from the existing Municipal Codes:

Chapter 10.54, which includes Sections 10.54.010 and 10.54.020, is hereby repealed.

**Section 2: Repealer**

All resolutions, ordinances and sections of the City of Harlowton Municipal Code in conflict herewith are hereby repealed.

**Section 3: Severability**








**Section 4: Effective Date**

The First Reading of this ordinance occurred on, and is reflected in the minutes of the City Council dated August 27, 2019.

This ordinance shall be in full force and effect 30 days after passage of the Second Reading.




